

#### Dog Writers Association of America 2008 Writing Competition Rules

Please read! There have been some changes made this year.

#### **Eligibility**

- 1. The contest is open to all writers, editors, publishers, photographers, artists and others whose work falls into the designated competition categories. The focus is always to be upon dogs.
- 2. The work must be original and must be published during the competition period from September 1st, 2007 through August 31st, 2008.
- 3. All entries must be published work.
- 4. Revisions, 2nd and additional revisions, and other re-writes of previously published work are not eligible for the contest even if the work had not previously been submitted.
- 5. There is no limit as to the number of times an individual or entity may enter; however, the same material may be entered only once in a regular category.
- 6. Entries must be postmarked by September 1, 2008. Late entries will not be accepted. No exceptions!
- 7. The contest chair retains the right to move entries to a different category, or disqualify an entry without notifying the entrant although a reasonable effort will be made to contact the entrant first.

#### **Submission Format**

- 1. Submit regular categories in triplicate with one entry form for each entry.
- 2. Submit one additional copy for each Special Award entry. Attach an additional entry form to each Special Award entry.
- 3. For a series, submit three sets of copies.
- 4. For columns, please submit your three best columns in triplicate. Only one three-column entry by the same author per publication is eligible.
- 5. Work may be photocopied or tearsheets may be submitted. No unpublished manuscripts or print-outs are acceptable except for syndicated newspaper work where original tearsheets are unavailable.

#### **Entry Fees**

- 1. Each regular category entry must be accompanied by a \$10 entry fee for current DWAA members and \$15 for nonmembers.
- 2. Each Special Award entry must be accompanied by a \$7 entry fee.
- 3. Please combine all entry fees in a single check or money order.
- 4. Make check or money order payable to "DWAA."

#### **Mailing Instructions**

- 1. Entries must be postmarked by September 1, 2008. No late entries will be accepted.
- 2. Mail entries to Liz Palika, DWAA Contest Chair, 250 Flame Tree Place, Oceanside, CA 92057.

- 3. Do NOT require a signature for delivery of your entry; the contest chair cannot be available all day every day to sign for packages.
- 4. Entries cannot be returned and the association is not responsible for entries lost during transit.
- 5. Arrival of entries cannot be personally acknowledged; I'm sorry but the contest is simply too large.

#### **Entrant Responsibilities**

- 1. It is the responsibility of the entrant to comply with all rules and guidelines. Deviation may result in rejection of the entry and forfeiture of the entry fees.
- 2. The maximum liability of the Association is limited to the refund of the entry fee at the Contest Chair's discretion.
- 3. Entries may be made on the behalf of someone else, but the name of the writer, photographer, website designer, or the person creating the work must be listed as the "entrant" and the person submitting the work is listed as the submitter. The submitter is responsible for receiving permission to submit the work prior to making an entry.

#### **Judging and Awards Information**

- 1. Each regular category entry will be judged by a panel of three judges, with a composite of the judges' scores determining the nominees and winners.
- 2. The decisions of the judges are final.
- 3. Nominees will be notified by mail in late December 2008.
- 4. Names of nominees will be published in the DWAA newsletter and on the website in January 2009.
- 5. Winners will be announced at the Awards Banquet on Feb 8, 2009.
- 6. Nominees in the regular categories will receive certificates; winners will also receive the DWAA Maxwell Medallion, named in honor of Maxwell Riddle.

#### **Special Awards**

- 1. Special awards are made possible through the generosity of individuals and organizations; and consist of certificates, plaques and/or cash grants.
- 2. An entry must be entered in a regular category to be considered for a special award.
- 3. Make sure the work being entered is appropriate to that special award. Work that does not fit the award description will be disqualified.
- 4. There will be no nominees in special awards categories.
- 5. Winners will be notified prior to the banquet.

# Book Reviews By Phyllis DeGioia


Grab Life by the Leash: A Guide to Bringing up and Bonding with your Four-legged Friend, by Cheryl S. Smith, Howell Book House, \$21.99, hardback, 242 pages

Trainer Cheryl Smith's wonderful guide is geared toward individual adults (not families), the ones who make the decisions and handle the training. What differentiates this book from other guides is the emphasis on why and how much people benefit from sharing their lives with dogs, which she refers to as the care crossover, rather than just teaching them how to train for specific activities or how to pick a good vet.

It's an overlook at all aspects of sharing your life with dogs: serious stuff, fun stuff, anal glands, mixed and same species introductions, matching dogs to human lifestyles, how dogs

sense the world (not like we do!) and far more. I am particularly fond of her "personal notes" amongst the many sidebars as they contribute greatly to the overall meaning.


Really, this is more of a primer than a guide, and Smith offers some terrific advice and shares a wealth of knowledge. Some of the wonderful black and white photos are contributed by DWAA's own Jean Fogle and Dr. Bernd Guenter as well as Smith herself.



See Spot Sit: 101 Illustrated Tips for Train-

ing the Dog You Love, by Carol Lea Benjamin, Skyhorse Publishing, \$12.95, paperback, 120 pages

This book is nothing short of amazing. It's written and illustrated by Benjamin, and I absolutely love her simple graphics that so perfectly illustrate her simple wisdom. (Side note: it's the same type of illustration she has drawn for this newsletter's masthead.) Her illustration on what a dog's body language is saying comes under the category of "a pic-



ture is worth a thousand words." This book is basic training and communication distilled into a book so simple children will understand the message.

This simple lesson is stunning in its effectiveness: "Your most important training tools cannot be purchased. They are voice, posture, and attitude." Throughout this book, there is no discussion of types of training, no clickers, no long leads to teach stay, no Gentle Leaders, "just" a lot of sensible stuff in a small, incredibly accessible package. This book makes an excellent refresher for all of us, and is a perfect must-have gift for people getting their first dog or puppy, or their first one in a long time.
