

EDITOR'S Desk



Never Forget

I was on my way to work in New York City when American Airlines flight #11 flew into the North Tower of the World Trade Center. I didn't see it happen, but I easily could have. My husband and I were driving across the Queensboro Bridge, with a clear line of sight down the East River toward lower Manhattan, the skyline dominated by the twin towers. Traffic was slow, so Larry was looking around. "The trade center's on fire," he said.

A couple of hours later Larry and I walked five miles back to Queens. The bridge had been closed to all traffic except emergency vehicles. We walked wordlessly with tens of thousands of other New Yorkers, also wordless. Sirens screamed nonstop, all headed downtown.

The next day I took the subway to work. I was the editor of ASPCA Animal Watch magazine, and we were a few weeks away from closing our Winter issue. Around noon I learned that the ASPCA president had lost his sister in the attacks. She was a flight attendant on hijacked American Airlines #11.

I don't remember what stories we'd planned for the section of the magazine called ASPCA News, or what photograph we'd chosen for the cover. I do know that these decisions would have been made by that date. The plans were scrapped so we could focus instead on what the ASPCA was doing to help the animals affected by the disaster. Many were still at home in evacuated high-rise apartment buildings around Ground Zero. Others were waiting in far-flung neighborhoods for owners who would not be coming home. Two ASPCA mobile veterinary units were stationed downtown to treat family pets and rescue dogs alike. An ASPCA psychologist was placed in charge of all the pet therapy teams that worked the Family Assistance Center where thousands of dazed family members came every day because that was where they were told to go for help.

Our art director found a new image for the cover of the magazine. I entered the entire issue in a contest the following year and it won a first place prize. On this anniversary I'm reprinting the cover here because I don't Intend to forget.

PRESIDENT'S Column

Could Reading Affect Breeding?

n 2008, in my first letter as your president I wrote, "DWAA. Four letters standing for four small words, but oh how big and important their meaning." My message focused on the professional career of a dog writer and the interactions provided by DWAA through the forum and the annual writing competition. I think that most dog writers know about the writing contest and know what a joy it brings to those who are recognized for their work. At the end of the day, what is important is how we use the talents we are given. Those who fear uncertainty or failure are not comfortable in this environment.

DWAA has a long history as a professional association, and that thought reminds me of our early members. They could not have imagined the tools we have available today that make writing so much easier. Computers and the Internet have revolutionized the life of the writer. Prior to 1990 very few writers had personal computers. Websites, chat rooms and email were ideas not yet imagined. These and many other technological changes have all come about in the past two decades.

In my last column I mentioned the study conducted by Dr. Jack Miller, president of Central Connecticut State University, in which Miller found that the Internet and new technologies have altered how and what the younger generation is reading. (The details of the study are online at www.ccsu. edu/amlc2010.) A significant finding was that people are reading more material but in less depth, with a preference for scanning over reading for in-depth understanding. In short, more material is being read, but readers are only getting briefed. This is a major concern because those who have the need to know and



understand what the writer offers might not be gathering enough information in sufficient detail. For example, in the knowledge-based world of owning, breeding and training dogs, this change in reading behavior has serious short- and long-term consequences. Think of it. In the past two decades more than \$80 million have been spent on research to dogs better and healthier. Technology has also provided volumes of new materials and better protocols such as risk management, formula breeding, techniques for managing carriers and the more than sixty DNA tests. Many of the new methods and protocols mentioned are now listed at www.breeding betterdogs.com. But as reading habits begin to shift toward scanning there will be less in-depth understanding of new research findings, which could adversely affect the technical advantage.

Two other questions linger in the background. What will transpire if breeders only read to be briefed? Can the next generation of writers become creative enough to reach their audience using condensed materials and fewer words? Only time will tell.



Electronic Newsletters = Big Savings

I belong to the Southern Maryland Audubon Society. Last year, they asked all members to consider receiving the society's newsletter, *The Osprey*, in electronic format. Many members agreed. In the most recent issue, the newsletter editor

announced that in fiscal year 2010, the society spent \$2,700.00 to print and mail the newsletter. This year, they spent only \$1,100.00 on mailing, a savings of 60 percent. The newsletter is beautifully done in full color, which of course is lost in the print version because they print in black and white to save money, just as DWAA does.

Right now about one-quarter of DWAA members have agreed to receive their newsletters electronically, saving DWAA about \$300 a year printing/mailing costs. If all members opted to read their newsletter online-in color!-we could realize a savings of roughly \$1,200 each year. The Membership Survey conducted by Dr. Mary Burch in 2009 found that 67 percent of those who completed the survey would be willing to receive their newsletter electronically, while 17 percent preferred a printed version. These findings suggest that more members should be contacting the secretary to sign up for the e-version. Twelve hundred dollars a year—every year!-may not be a huge sum, but I'm sure we could come up with some excellent suggestions for ways to put that amount to very good use.



Legal Advisor's Update

Update on Embezzlement

I have spoken with the Assistant DA in charge of prosecuting the case against Rue Chagoll. As you know he is charged with a felony and has confessed in writing and on tape. While the fact that this is the first offense with which he has been charged works in his favor, the sheer amount taken over a multi-year period has convinced the State of NY to charge him with a felony.

The case stands like this right now: The DA has made a pre-indictment proposal to Rue and his attorney. Rue may plead to a misdemeanor at his indictment [held on 16 September 2011—Ed.] if—and this is a big if—he repays the entire amount he embezzled from DWAA at the time of the indictment. There is no offer of repayment plans etc. or promises or restitution. It has to be repayment of the full amount.

If he cannot repay the full amount at indictment, the DA will prosecute him for a felony and demand jail time. The amount of time will be in the discretion of the judge under the statutory guidelines. He would likely do his time in county jail and, once released, would be required to provide restitution of the amount embezzled. Given that we understand Rue is already on payment plans to the IRS and for back child support, the likelihood of our recovering any money is pretty slim. Especially since, as a convicted felon, it would be difficult for him to find post-incarceration employment.

Doing the time in county rather than in a state prison is predicated on his acknowledging his confession. If he tries to repudiate his confession, or otherwise challenge it, the DA will request, upon conviction, that Rue do hard time in the state prison.

The indictment comes from the Grand Jury, and the DA is hoping that the statement of fact which the NY State investigator and we drafted and which Pat Santi signed during her time in NY State for the DWAA meeting will be sufficient. Otherwise, we may need to make plans to have a DWAA officer go to Ithaca to testify to the facts.

New York State Investigator Wins Praise From DWAA

I was very impressed with the individuals in New York who worked with me on our embezzlement case, especially the New York State trooper who investigated the case and prepared it for presentation to the DA. He was also the one who confronted Rue in such a way that he confessed immediately. I wrote a letter to his superior officer commending his diligence and expressing our appreciation. My letter is reprinted below:

Dear Major Molinari:

I am writing to express my and the Dog Writers Association of America's appreciation for the excellent investigative work performed by Investigator Aaron Lewis during the recent investigation of the embezzlement from our nonprofit association.

Due to Investigator Lewis' diligence, the DWAA's former treasurer faces an indictment for the embezzlement of over \$71,000 during his tenure as an association officer. While nothing is assured, we now have at least a chance of recovering some of these funds.

The investigation of crimes such as this can be tedious and requires determination and attention to detail, especially, as in our case, when even our bank initially resisted providing the necessary information to pursue the case successfully. But Investigator Lewis persisted and, by gathering a complete body of evidence, and confronting the former treasurer with his results, obtained a taped and written confession.

During the period of the investigation, Investigator Lewis was always responsive to our requests and kept us up to date on his progress. We all really appreciate his work and wanted to be sure he was recognized for his dedication.

Writing Tips

recently learned about a blog and website called Daily Writing Tips (www.dailywritingtips.com). Here's the tip from August 17, 2011:

"Every time I use they as a singular pronoun in my writing, someone posts a comment scolding me for my grammatical error. I (politely) tell them to get over it.

"Granted, multiple grammatical strategies are available for people to identify someone with a personal pronoun, each of which can be used exclusively or in combination with one or more of the others:

"Use the male gender: 'Each person is entitled to his opinion.'

"Use the female gender when all possible referents are women: 'Each nun is entitled to her opinion.'

"Use both male and female genders: 'Each person is entitled to his or her (or his/her) opinion.'

"Alternate gender references: Each person is entitled to his opinion. However, she should also be receptive to those of others.' (This strategy is best employed with distinct anecdotes in separate passages; otherwise it's awkward, as this example shows.)

"Use an indefinite article in place of a pronoun: 'Each person is entitled to an opinion.'

"Recast the sentence to plural form: 'All people are entitled to their own opinions.'

"I've used most of these strategies. However, there is an additional option: 'Each person is entitled to their opinion."

I, too, have used most of these strategies. But I haven't used the last one. I think it breaks a cardinal rule, that of agreement between a noun and its pronoun. However, the author of the daily tip goes on to justify the additional option. It's food for thought.

This is the kind of content that *Daily Writing Tips* sends to my inbox five times a week. The website has lots of extras: grammar, spelling and vocabulary tests, competitions, and archived articles in categories that include expressions, punctuation and misused words. The daily tip is a quick read that gets the writerly juices flowing, like the singer who does scales to warm up her voice ("Their voices"? I don't think so....).

An Interview With Nona Kilgore Bauer

n 2006 BowTie Inc.'s Kennel Club Books division published Dog Heroes of September 11th: A Tribute to America's Search and Rescue Dogs, written by long-time Golden Retriever breeder and author, Nona Kilgore Bauer. This year, ten years after the terrorist attack on America, BowTie published a Tenth Anniversary revised and updated edition of Dog Heroes of September 11th and sent Nona to New York City in early September to do a week-long media tour. A member of DWAA since 1992, Nona agreed to talk with us about the path that brought her to this place.

Ruff Drafts: Let's begin at the beginning. Are you first and foremost a dog person or a writer?

Nona Kilgore Bauer: Gosh, today I really cannot distinquish between the two. I've been writing "something" since grammar school ...poetry, a silly play with scenes and all when I was in fifth grade. I started writing professionally thirty years ago when my husband and I first moved to our farm here in Missouri, first as an advocate for dogs and dog legislation. I submitted articles to our local newspapers and was soon writing feature articles for newspapers and dog features for magazines. So while I do consider myself a writer, my dog life always came firsttraining for field trials and hunt tests for so many years. Happily it's been Goldens and Labs since writing my first book on Golden Retrievers in 1991.

RD: What or who can you point to as helping to advance your career as a dog writer?

NKB: Breeding and training Golden Retrievers since 1975 has of course been a huge connection to the world of dogs. Part of my breeding program included detailed monthly letters to my puppy owners, explaining each puppy stage, what to expect and how to deal with that behavior, training tips, advice, encouragement, etc. I also sent each family a birthday and Christmas card every year for the dog's lifetime to remind them I was their dog's grandma and still there for any questions or problems that might arise. Those letters and the supporting material I included certainly provided fodder for articles and books later in my writing life.

My first book, *The World of the Golden Retriever*, launched my career as an author. I still get a tingle when I say that, by the way. I am forever indebted to Chris Walkowicz [DWAA member since 1983 and president from 2000-2004], who in 1991 suggested my name to Andrew DePrisco, then an editor at TFH, to write that first book. What began as a small breed book became a huge tome that took me two and a half years to write. Fortunately Andrew gave me a long leash and let me keep writing...and writing...and writing. I've worked with him on about two dozen books since then, including several more on Goldens. He's been a great friend

and support these past twenty years.

In 1998 I was approached by Alpha Books to write *The Complete Idiot's Guide to Golden Retrievers*, and two years later, Dominique DeVito, editor at Wiley Publishing, asked me to write *Golden Retrievers for Dummies*. I'd worked with Dominique during her years at AKC Gazette. The *Dummies* book is still the "bible" that most Golden breeders recommend to their puppy buyers.

RD: So tell us how Nona Kilgore Bauer from LaBelle, Missouri came to be the author of *Dog Heroes of* September 11th?

NKB: It began with a photograph of a Search and Rescue Golden Retriever named Louie who was sitting amid the smoldering wreckage of Ground Zero. A friend of mine had bred Louie and showed

me his photo. The picture captured the sadness and enormity of the disaster site, and I sent a copy of it to my editor—yes, the same Andrew DePrisco, now with BowTie, Inc.—hoping he'd include it in a breed book about Goldens I had just finished writing. He called me the day he received it and suggested I write a book about the 9/11 search and rescue dogs.

Initially I resisted, not wanting to revisit such a tragic time in our nation's history, but a bit of research convinced me otherwise. I knew that trained dogs like Louie had been utilized after the attacks, but like most Americans, I was unaware of what those search and rescue dogs really did and how vital their work was in locating victims. And I concluded that if I, a dog person, didn't know about their work, then the

average American probably didn't either. So Louie's photo launched my mission to recognize and honor those brave dogs and handlers. Without their work, thousands of families would not have found the closure that comes with the return of a family member or a beloved friend. That contribution is priceless, and America needed to know that.

RD: You've said that writing Dog Heroes of September 11th has changed your life. What do you mean by that?

NKB: It was such a privilege to be invited into the lives of

the amazing people who worked during 9/11. My research led me to a corps of handlers who at first were reluctant to share their stories with a stranger who might exploit them or their dogs. However, once we connected as fellow dog trainers. they referred me to scores of other handlers from rescue groups across the country...one handler led to another, and it just evolved and grew beyond the twentyfive dogs we had initially hoped to reach. I was moved experiences at the honored that they

their stories with my readers. These teams of dedicated professionals train year round, most at their own expense, many for years in order to be ready "just in case." When I said to them, "Thank you," they turned around and thanked me, grateful that their dogs were being recognized.

During the course of these interviews, I met Wilma Melville, the founder and executive director of the National Disaster Search Dog Foundation based in Ojai, California. When disaster struck New York on 9/11, NDSDF deployed thirteen teams to the World Trade Center; all but one of those teams were FEMA Advanced Certified. Wilma herself had answered a similar call in 1995 when she and her FEMA-certified black Labrador, Murphy, were deployed to Oklahoma City to help search for victims after the bombing of the Murrah Federal Building. That life-changing experience led Wilma to embark on a personal mission to create a training program that would train more dogs and handlers, train them faster and more cost-effectively. Her foresight and dedication have enriched the Urban Search and Rescue world with several dozen advanced teams, all ready to serve their communities and country. And her vision continues, with the construction of a multi-million dollar national training center designed to produce highly trained canine disaster search teams. On a personal note, I'm delighted to report that two Labrador pups of my own breeding were accepted into the NDSDF training program. In my thirty years of breeding Golden and Labrador

Retrievers, I am proudest of my two pups who are serving our country today.

RD: Both in 2006 and again this year with the tenth anniversary edition, you were asked to do some major media to promote sales of the books. How did you prepare for being in the spotlight this way? Were you born to be in front of a camera?

NKB: I definitely was *not* born to be in front of a camera...I am actually kind of shy with new people. But I am so

passionate about these SAR teams and how they serve that it just flows from my heart. In 2006 I did prepare a few things to say during Book Expo America, and I've leaned on that these last five vears, but I find that once I start talking about my heroes in the book, I'm on a roll.

RD: What would you say have been your writing goals? Have they changed over time? What do you think or hope lies ahead for you as a writer?

NKB: I have always hoped to enrich the their families, and to

educate people about the value of the human/canine relationship. Since the 9/11 book I've been involved with the Search Dog Foundation, and they have become an important part of my writing life. I plan to continue to support and work with them.

Remembering Charlotte Schwartz

he life of a dog trainer like Charlotte Schwartz was never dull. Instructor to thousands of owners and their (formerly) naughty dogs, at the age of 82 Charlotte continued to teach daily lessons at the Coral Veterinary Clinic in Fort Myers, Florida. Her training career was varied: she taught dog behavior to veterinarians in Tasmania, trained dogs and capuchin monkeys to assist the handicapped, worked with messenger dogs, drug detection dogs, and tracking dogs, and trained all levels of obedience as well as exhibition teams.

While living in New Jersey, Charlotte founded the Brandy Lane Farm Dog Training School. She emphasized motivational training techniques years before positive training was the thing to do. She had a unique way of understanding a dog, and she preached her "View from the Floor" sermon to hundreds of dog trainers across the country. Charlotte was a member of American Pet Dog Trainers and the Anglo-American Dog Trainers.

She was known as a tough trainer with a no-nonsense approach, but beneath that tough exterior was a personable, passionate woman who loved quilting, birding, lunching, and writing about and talking dogs. Just a week prior to her passing, she called me at BowTie to pitch a new book idea she was burning to write.

A member of the DWAA, Charlotte wrote for most major dog-book publishers, and her most celebrated volumes focused on her favorite topic—puppies! The Howell Book of Puppy Raising and her best-selling Puppy Training (Kennel Club Books) are just two of the dozens of books she authored. She loved Toy Poodles and was lost without one. She died at home on September 5, 2011, and is survived by her grandson Brett Tougas, his wife Melissa, their two children, and her Toy Poodle Berry.


